CONTEST RULES

1. The contest shall be held at the German-American Festival, in the Schwabenhalle at Oak Shade Grove located at: 3624 Seaman St., Oregon, OH on Sunday August 29, 2010. Directions etc. at www.gaf.society.org. Judging will start at promptly at 4:15 p.m. Please **arrive by 4:00 p.m. and sign-in!!**
2. Children must be ages 2-10 at the time of the contest. Children or their sponsor DO NOT need to be a member of any of the seven Societies which sponsor the German-American Festival.
3. Participants shall imitate a **M.I. Hummel** figurine. Submit the mold number (HUM#) on the registration form. **ONLY M.I. HUMMEL** figurines may be imitated (Berta Hummel, Schmid, Dubler or any other Hummel variations are not accepted for this contest). **Each entrant must submit a registration form to the chairman no later than August 14, 2010. After that date applications or changes in mold number cannot be accepted.** Please advise the chairman if you withdraw after submitting an application.
4. Children will be judged on Overall Look; Costume and Props; Pose and Facial Expression. Pose held for one minute. The judges will be using images of the figurines provided by the M. I. Hummel Club as the official reference. Several books are available for reference as well as online at www.mihummel.com; you may use any of these sources for your reference but note the official reference for the judges. If you are using displays please submit a picture/source of your reference to chairman (some online stores are combining scapes and figurines in other than the original releases).
5. Children shall be judged in age groups: 2-3-4 years; 5-6-7 years; 8-9-10 years. Judging will be from youngest to oldest. Children will be judged **ONLY** once.
6. Judges will not be members of any of the seven Societies which sponsor the German-American Festival. Names of the contestants will not be known to the judges prior to the contest. **JUDGES DECISIONS SHALL BE FINAL.** Judges are not to be challenged in any manner on their scoring or decisions. Please refrain from talking with the judges and/or committee members during the contest.
7. One application per figurine. If several children are in the pose, include all names on one form. Please note that if more than one child poses for a figurine and the place standing is awarded a Hummel figurine, only one Hummel will be received.
8. Each child will receive a certificate of participation from the German-American Festival.
