- Your free hand may not be used to prop up the Masskrug,
- If the arm holding the Masskrug is not absolutely parallel to the floor, the contestant gets a warning. The contestant will be disqualified after 2 warnings.
- **Touching another contestant is an automatic disqualification.**
- **Any spilling of beer is an automatic disqualification.**

- Neither G.A.F. Society, d/b/a German-American Festival or any of its officers, member Societies, or members can be held responsible for any injuries that occur in connection with the competition.

- G.A.F. Society, d/b/a German-American Festival or any of its officers, member Societies, or members do not encourage drinking. Even though Masskrugstemmen involves a 1 liter Stein filled with beer, the event organizers strongly encourage all contestants and audience to drink safely and responsibly and not to drive or operate machinery when under the influence of alcohol.
